## Executive summary

We tested **PCProtect** (version 5.15.69) between November 29, 2021 and November 30, 2021, on Microsoft Windows 10 Pro N, 64-bit, 10.0.19043, as per the 1.3 version of the VB100 methodology.

**The tested product has successfully met the VB100 test criteria.**

### Test criteria:

- The product must detect at least 99.5% of all test cases in the Certification set (malicious samples).
- The product must not generate more than 0.05% false alarms in the Clean set (legitimate program samples).

The VB100 test uses multiple sets of malicious and clean test cases to verify the ability of the tested product to detect malware, and to do so without generating false alarms for legitimate programs.
